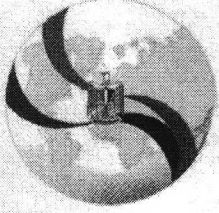

In reference to the Egyptian Government actions to implement single window concept and reference to the Minister of Finance decree number 38 for year 2021 regarding the Mechanism for Advanced Cargo Information System,

I have the pleasure to inform you that, the Egyptian Government launched a new portal for Advanced Cargo Information System (ACI) that requires cargo data and documents at least 48 hours before the cargo shipment from export country, in order to issue the reference number (ACID) and have it registered on all documents.

The Pilot phase of (ACI) will start on 1<sup>st</sup> of April 2021, and the mandatory operation will be starting from 1<sup>st</sup> of July, 2021, all information related to the newly implemented Advanced Cargo Information System (ACI) can be found at [www.nafeza.gov.eg](http://www.nafeza.gov.eg).

We kindly ask you to disseminate the above mentioned information between member companies of your esteemed institution to avoid any future disruption in trade and please do not hesitate to contact us for any further clarifications.
