İlgi : Ticaret Bakanlığı'nın 24.02.2026 tarih ve E-84261457-590-00119336213 sayılı yazısı.

İlgide kayıtlı yazıda, Nairobi Ticaret Müşavirliği'nden alınan bir yazıya atfen, Kenya Standartlar Bürosunun 19 Şubat 2026 tarihinde yayınladığı, bir örneği ilişik (Ek-1) İhracat Öncesi Uygunluk Denetimi Kılavuzu'nda aşağıda belirtilen bazı önemli değişiklikler yapıldığı belirtilmektedir.

Bu kapsamda;

- Uygunluk belgesi alınması için yapılacak başvurularda, uygunluk belgesi vermeye yetkili denetim firmasına Serbest Satış Sertifikası sunulması gerektiği,
- Kenya tarafından ithalatçının da aynı Serbest Satış Sertifikasını gümrük idaresine sunmak zorunda olduğu,
- Ülkemizde Uygunluk Denetimi yapmaya yetkili şirketlerin SGS, Intertek, TUV Rheinland & BV olarak belirlendiği,

ifade edilmekte ve kılavuzda belirtilen Serbest Satış Sertifikasının kim tarafından, hangi şartlarda düzenleneceğinin karara bağlanması talep edilmektedir.

Yazıda devamla, serbest satış sertifikalarının, ürün güvenliği mevzuatı ve denetim altyapısı gelişmiş olmayan bazı ülkeler tarafından ithalatta talep edilen, yasal olarak ürünün ilgili mevzuatına uygun bir şekilde piyasada arz edildiğini gösteren, ithalatçı ülkenin kendi ürün mevzuatı değil sadece ihracatçı ülkenin kendi ilgili mevzuatına uygunluğun arandığı, bu anlamda firmalarımızın ihracat pazarlarına girişte karşılaştığı belgelerden en hafifi olan, bu doğrultuda ürün ve mevzuat bilgisi gerektirdiğinden ilgili üründen sorumlu yetkili kuruluş tarafından düzenlenmesi gereken belgeler olduğu ifade edilmektedir.

İlave olarak, ithalatçı ülkelerin talepleri doğrultusunda ihracatçılarımızdan zaman zaman talep edilen serbest satış sertifikalarının, ilgili kamu kurumları tarafından görev alanlarına giren ürünler kapsamında düzenlenerek ihracatçılarımızın kullanımına sunulduğu ifade edilmektedir. Bu kapsamda, yetkili kuruluşlar ile sorumlu oldukları ürün gruplarının listesi ekte (Ek-2) sunulmakta olup Kenya'ya ihracat yapacak firmalarımızın serbest satış sertifikası temin edebilmeleri için, ilgili ürün grupları çerçevesinde yetkili kuruluşlara başvuruda bulunmaları gerektiği belirtilmektedir.

# **PVOC PROGRAM OPERATIONS MANUAL**

**Version 15, Date: 19<sup>th</sup> February 2026**

## 1. INTRODUCTION

The Kenya Bureau of Standards (KEBS) is a statutory body established under the Standards Act, CAP. 496, Laws of Kenya, mandated to provide quality inspection of imports based on Kenya Standards or approved specifications, among other services. KEBS inspects imported goods either in the country of export through the Pre-Export Verification of Conformity (PVoC) to Standards Programme or at the destination/Ports of Entry.

This Manual provides detailed guidance on the inspection of imported goods in the country of export under the Pre-Export Verification of Conformity (PVoC) Programme. Guidance on Destination Inspection is set out in **destination inspection manual**.

### 1.1. *General Overview of the PVoC Program*

PVOC Program is a conformity assessment program applied to products at the respective exporting countries, to ensure their compliance with the applicable Kenya standards, approved specifications, and other applicable regulations.

### 1.2. *Legal Basis of the PVoC Program*

PVOC program was started on 29<sup>th</sup> September 2005 by KEBS, through the publication of Legal Notice No. 78 of 15<sup>th</sup> July 2005 by then Minister for Trade and Industry. This Legal Notice was superseded by Legal Notice No. 127 of 19<sup>th</sup> June 2018. On 12<sup>th</sup> November 2019, the Cabinet Secretary, Ministry of Trade, Industry and Co-operatives revoked this Legal Notice and issued Legal Notice 183.

On 28<sup>th</sup> April 2020, Legal Notice 183 was revoked and replaced with Legal Notice 78 (2020). There have been further amendments to Legal Notice 78 (2020) to improve the program as listed below:

- i. Legal Notice 212 (18<sup>th</sup> December 2020)
- ii. Legal Notice 53 (22<sup>nd</sup> April 2021)

The program is also compliant with the provisions of Article 5 of WTO TBT Agreement.

### 1.3. *Objectives of the program*

- To ensure quality of products, health and safety, and environmental protection for consumers.
- To facilitate trade by ensuring that compliant goods are given expedited clearance at the port of entry.
- To safeguard the country from unfair trade practices and dumping of substandard goods by ensuring that imported products comply with the same requirements to which locally manufactured goods are subjected.
- To safeguard the country's national security.
- To prevent deceptive trade practices.
- To enhance efficiency of clearance of imported goods at the ports of entry

### 1.4. *Operations of the Program*

- The Programme is implemented by contracted inspection companies that provide PVoC services to suppliers and exporters of goods destined for Kenya.
- The exporting countries are grouped into eight (8) Zones as detailed under clause 5.2 below.
- Goods from countries NOT covered under the program will be subjected to destination inspection. These countries are listed under clause 5.3 below
- The basis of certification is Kenya standards, approved specifications, and other applicable regulations.

## 3. RESPONSIBILITIES UNDER THE PVOC PROGRAM

### 3.1. Importers

- To request PVoC services by submitting a request for certification (RFC) to PVoC Contractors.
- Obtain the applicable Kenya Standards from KEBS and share the requirements with their suppliers.
- Obtain other regulatory import requirements applicable to their imports and share with their suppliers.
- Ensure that only goods meeting the requirements of the applicable Standard or approved specifications and issued with CoC or CoR are shipped to Kenya. Goods not meeting the applicable requirements and issued with NCRs shall not be shipped to Kenya.
- Ensure that consignments that are not accompanied by CoC, or CoR as required, are presented to KEBS for destination inspection and/or testing prior to release from the Port of Entry.
- To obtain a Free sale certificate from the exporter and present the same to KEBS at the port of Entry.

### 3.2. Exporters

- Ensure their products or goods meet the requirements specified in relevant Kenya standards, approved specifications, and other applicable regulations before shipment by carrying out tests and facilitating physical inspection, where required, by PVoC Contractors.
- Ensure that the consignments have been issued with a CoC, or CoR by PVoC Contractors for all products subject to the PVoC program before shipping.

c) Obtain and submit Free Sale certificate to the PVoC contractor before CoC issuance

**Note:** *Importer or exporter is required to confirm the details in the CoC/CoR draft given by the PVoC Contractor before issuance of the final CoC/CoR. KEBS will not allow amendments after issuance. Exporters/Importers must confirm details in the draft CoC/CoR within 48 hours of receipt of the draft from PVoC contractor, failure to which the same shall be issued as is.*

### 3.3. PVoC Contractors

Nine (9) inspection companies (PVoC Contractors) have been contracted by KEBS to undertake PVoC activities from the year 2026 to 2029. These are;

#### a) General Goods

- ii. China Hansom Inspection and Certificate Co. Ltd.(CHIC)
- iii. ASTC As Test Certification Tech. (Hangzhou) Co. Ltd.(ASTC)

- v. Intertek International Limited.(INTERTEK)

- vii. TÜV Rheinland Middle East FZE.(TUV Rheinland)
- viii. Bureau Veritas Kenya Limited.(BV)
- ix. Société Générale De Surveillance SA.(SGS)

#### b) Motor Vehicles, Motor Vehicle Spare Parts, and Mobile Equipment

- i. Quality Inspection Services Inc. Japan (QISJ)

The role of PVoC Contractors is to undertake conformity assessment activities in the assigned zones. These activities include inspection, sampling, testing, sealing of full-load containers (where applicable) and issuance of COCs/ CORs / NCR.

The inspection shall be scheduled in liaison with the exporter. The physical inspections shall be undertaken within four (4) working days and one (1) working day of receipt of the duly completed Request for Certification Form from the exporter for sea bound shipments and one air freight shipment respectively unless a different date is requested in writing by the exporter.

Issuance of Certificates of Conformity for compliant consignments shall be within two (2) working days and one (1) working day of receipt of final documentation and meeting payment terms by the exporter/importer for sea bound cargo and air freight cargo respectively.

### 3.4. KEBS

Ensure that only goods meeting the requirements of the relevant Kenya Standards or approved specification enter the country as provided for in the Standards Act Cap 496, Laws of Kenya, and the Standards (Verification of Conformity to Standards and other Applicable Regulations) Order, 2020.

### 3.5. Partner Government Agencies

All other government agencies with mandate over international trade operations shall continue to remain accountable for the discharge of their respective mandates in accordance with existing legal frameworks, but subject to adherence with the guidelines provided by the Government circular reference OP/CAB 9/83A dated 4<sup>th</sup> June 2019.

#### 4. PVOC SCOPE

All imported goods destined to Kenya from countries listed under clause 5.2, including those regulated by other Partner Government Agencies except those listed in the schedule of the Legal Notice No. 78 of April 2020 (Annex 3), shall undergo mandatory certification in the country of origin or supply prior to shipment into the country failure to which the same shall be subjected to destination inspection and/or testing in accordance with paragraph 9 of the Legal Notice 78 (2020).

#### 5.4. Testing of Products

The test reports considered for certification shall be from a recognized laboratory or as guided in the table below.

No.	Category of Goods	Test Report	Remarks
1.	Consumer products	Use of test report from recognized lab	In absence of these laboratories, PVOC contractors may undertake the witness testing of the product to inform them of their certification decision.
2.	Machinery and spares	Use of internal test reports from Manufacturer's lab	The manufacturer Lab must be certified to ISO 9001.
3.	Medical equipment (except medical consumables)	Use of internal test reports from Manufacturer's lab plus a permit from the Pharmacy and Poisons Board (PPB)	The manufacturer Lab must be ISO 13485 certified.
4.	Automotive parts and spares	Use of internal test reports from Manufacturer's Lab	The manufacturer Lab must be IAFT 16949 certified.
5.	Chemicals/raw materials without applicable Kenya Standards	Use of internal test reports from Manufacturer's Lab	The manufacturer Lab must be certified to ISO 9001.

#### 5.5. Certification Routes for General Goods

There are three (3) possible routes for obtaining the CoC under the PVOC program. The route applied depends on the risk assessment conducted by the PVOC contractor upon receipt of a request for certification from the exporter/supplier.

##### 5.5.1 Route A (Consignment inspection and Testing)

Under this Route, products to be shipped must be both tested (as specified under clause 5.4 above) and physically inspected to demonstrate conformity to relevant standards and regulatory requirements. Additionally, all containerized cargo under this route from China and United Arab Emirates must be sealed by the PVOC contractor and seal and container numbers indicated in the CoC.

However, the following products are only eligible for certification under route A regardless of the outcome of the risk assessment conducted by the PVOC contractor.

- Animal and Fishery products (fresh and frozen - not further processed)
- Bulk Petroleum products and base oils
- Bulk shipments of cereals and pulses such as rice, wheat, beans, maize etc.
- Edible cooking oils
- Fertilizer

- Fresh dairy products
- Fresh horticultural produce
- Liquid Petroleum Gas (LPG)
- Sugar
- Used or secondhand goods.

### 5.5.2 Route B - Product Registration

This route offers a fast-track certification process for goods of low risk but with reasonable and consistent levels of quality through registration of such products by the PVoC Contractor. Product registration is recommended for exporters having frequent shipments of homogeneous products. Among the mandatory documents required for registration are test report(s) from any of the recognized laboratories issued in accordance with clause 5.3 above for previous shipments certified under Route A demonstrating conformity to relevant Kenya Standards or approved specification. The registration is valid for a period of one year.

PVOC contractor shall conduct risk assessment for each request for certification of registered products to determine the level of intervention required before issuing the COC. However, the PVOC contractor is obliged to conduct at least 2 surveillance inspections and testing within the registration validity period.

### 5.5.3 Route C - Product Licensing

This route is open only to manufacturers who can demonstrate existence of a quality management system in their production/ manufacturing process. It involves auditing of such production processes and licensing of products manufactured thereof by authorized PVoC Contractor(s) in line with ISO IEC 17067. Products presented for licensing shall be subjected to testing in any of the recognized laboratories in accordance with clause 5.4 above to determine their conformity with requirements of relevant Kenya Standards or approved specifications. On successful conclusion of this process, the manufacturer will be presented with a License for the relevant products valid for a period of three (3) years or as determined by the PVoC contract validity period.

PVOC contractor shall conduct risk assessment for each request for certification of licensed products to determine the level of intervention required before issuing the COC. However, the PVOC contractor shall conduct factory surveillance inspection and testing as guided by ISO IEC 17067.

## 5.6. Fees Charged Under the PVoC Program

- **Route A:** 0.60% of the FOB Value min USD 300 max USD 3500
- **Route B:** 0.55% of the FOB Value min USD 300 max USD 3500
- **Route C:** 0.50% of the FOB Value min USD 300 max USD 3500

The above fees cover documentary verification, physical inspection and sampling, including sealing of the containers where applicable. The fees do not include: -

- Laboratory testing
- Manufacturer Licensing
- Registration fees
- Sampling of Bulk shipment
- Re-inspection.

These services shall be charged directly by the contractor on a case-by-case basis.

## 5.7. Enriched Certificate of Conformity

The Government through a Government circular reference **OP/CAB 9/83A** dated 4<sup>th</sup> June 2019 directed that the number of government agencies operating at the port be reduced from 28 to 4. For the purposes of ensuring conformity to quality standards and the adherence to other regulatory requirements for cargo entering the country, KEBS was mandated to be the lead agency for the purpose of coordinating the inspection of goods at the country of origin and the issuance of enriched CoCs where goods comply with the requirements and issue an NCR (Nonconformity Report) to goods that do not comply to requirements.

- Consignments issued with NCR shall not be allowed entry into Kenya.
- Goods issued with NCR by a PVoC Contractor shall not be presented to another PVoC contractor for certification.

## 6. MOTOR VEHICLES, MOBILE EQUIPMENT AND USED SPARE PARTS THEREOF

### 6.1. Motor Vehicle, Mobile Equipment and Spare Parts Inspection

KEBS has appointed QISJ to offer Pre-Export Verification of Conformity services in the following five (5) Countries:

QISJ handles the inspection of:

- i. Used Vehicles, in accordance with **KS 1515 - Code of Practice for Inspection of Road Vehicles** and for the inspection of used vehicles for radioactive contamination and verification of odometer integrity.
- ii. Mobile equipment in accordance with relevant Kenya Standards or approved specification.
- iii. Used spare parts for vehicles and Mobile equipment in accordance with relevant Kenya Standards or approved specifications.

#### Note:

1. All road vehicles classified as written-off, salvaged, or converted must be accompanied by a Certificate of Repair and a verifiable chassis alignment report issued by an authorized garage before being subjected to roadworthiness inspection.
2. Radiation contamination inspection will be undertaken for all used vehicles, Mobile Equipment and Spare parts from **Japan** and **United Arab Emirates**. It is a mandatory requirement that vehicles, Mobile Equipment and Used spare parts coming from the countries listed in the table above are subjected to inspection to demonstrate conformity to the relevant standard before shipment and must be accompanied with CoRs or COCs. Used vehicles, mobile equipment and spare parts from the aforementioned countries at the port of entry without a CoC or CoR shall be subjected to destination inspection in accordance with paragraph 9 of Legal Notice 78 (2020).

## 7. CONSIGNMENTS ISSUED WITH NON-CONFORMITY REPORT (NCR)

- Consignments issued with NCR shall not be allowed entry into Kenya.
- Goods issued with NCR by a PVoC Contractor shall not be presented to another PVoC contractor for certification.

## 8. IMPORTS FROM COUNTRIES WHERE PVOC CONTRACTORS ARE NOT PRESENT

General goods and used motor vehicles being imported from countries where PVOC Contractors are not present (see clause 5.3 and 6.1) shall be subject to destination inspection upon payment of destination inspection fee equivalent to 0.6% of the approved Customs Value subject to minimum of USD 300 and maximum of USD 3500 per used motor vehicle unit or consignment submitted for inspection. Testing fee is payable where testing is required to determine conformity.

## 9. EXEMPTIONS AND WAIVERS FROM PVOC

Criteria for exemption of specific importers from PVoC requirements is as given in Annex 1.

Other request for waivers shall be handled in accordance with the provisions of Legal Notice No. 78 of 28<sup>th</sup> April 2020, Clause 10 as per the Waivers Evaluation Technical Committee (WETC) criteria in **Annex 4**. The importers seeking for waiver shall write to KEBS seeking for waiver and providing all the required documentation for review.

## 10. CERTIFICATION OF USED CLOTHING AND SHOES

### 10.1 Accreditation of Mitumba baling facilities

Facilities for sorting and baling of used textiles and used footwear meant for Kenya will be required to be accredited by PVOC contractor, and the details shared with KEBS as per the **Protocol for Importation of Used Textiles and Used Footwear**.

### 10.2 Registration of importers of Used Textiles and Used Footwear

Importers of Used Textiles and Used Footwear will be required to be registered with KEBS and be issued with a registration certificate

### 10.3 Certification of Used Textiles and Used Footwear

For certification of used textiles and footwear, the exporter baling facility must be accredited by the PVoC contractor, while KEBS shall register the importer for an RFC to be accepted. Inspection shall be conducted by the PVoC contractor to determine compliance with KS EAS 356:2019: and KS 1533: 1999. COC shall be issued to compliant consignments supplied by accredited sorting and baling facilities. All shipment containers for Used Textiles and Used Footwear must be sealed by the PVoC inspection company after inspection.

### 11. HANDLING OF IMPORTS AT PORT OF DESTINATION (KENYA)

- Goods arriving at the port of entry with a certificate of conformity will be given direct release. However, targeted consignments may be released conditionally pending surveillance testing.
- Copies of CoR and CoC must be submitted to both KEBS and KRA through the Kenya National Electronic
- Single Window System (“Single Window”) to facilitate cargo clearance at the Ports of Entry.
- Other Import documents to be submitted through the Single Window, for KEBS clearance are:
  - i. Customs Approved Entry
  - ii. Bill of Lading
  - iii. Import Declaration Form (IDF)
  - iv. Invoice
  - v. Packing list
  - vi. Genuine, authentic Warranty type approval for New Motor vehicle spare parts, New Motor vehicle, and mobile equipment (where applicable).
  - vii. Permits and approval by other Partner government agencies (where applicable).
  - viii. Free sale certificate (For general goods).

LEGAL NOTICE No. 78

**THE STANDARDS ACT***(Cap. 496)*

IN EXERCISE of the powers conferred by section 20 of the Standards Act, the Cabinet Secretary for Industrialisation, Trade and Enterprise Development, in consultation with the Council, makes the following Order—

**THE STANDARDS (VERIFICATION OF CONFORMITY TO STANDARDS AND OTHER APPLICABLE REGULATIONS) ORDER, 2020**

**PART I—PRELIMINARY**

1. This Order may be cited as the Standards (Verification of Conformity to Standards and Other Applicable Regulations) Order, 2020.

Citation.

2. In this Order, unless the context otherwise requires—  
"Bureau" means the Kenya Bureau of Standards established by section 3 of the Act; and

Interpretation.

"Council" means the National Standards Council established by section 6 of the Act.

3. This Order shall apply to all products imported into Kenya.

Application.

4. (1) Notwithstanding any other provision of this Order, the products specified in the first column of the Schedule shall be exempted from the provisions of this Order:

Exempted products.

Provided that a person importing any exempted product specified in the Schedule shall provide the documents specified in the second column of the Schedule with respect to the exempted product.

(2) The products specified in the Schedule may be inspected on arrival at a port of entry.

5. (1) An importer of products shall ensure that the imported products meet Kenya standards, approved specifications and other applicable regulations.

Compliance with standards.

(2) An importer of products shall notify the Bureau in the prescribed form before importing any product into Kenya and provide proof that the imported product meets Kenya standards, approved specifications and other applicable regulations.

6. (1) The Bureau may appoint an inspection body in the country of exportation of products, or in a transshipment port, or in a

Appointment of inspection bodies.

port of entry, to undertake verification of conformity to Kenya standards, approved specifications and other applicable regulations.

(2) The Bureau may recognise a national standards body of an exporting country that performs inspection functions as an inspection body for the purposes of pre-shipment verification of conformity.

7. (1) Any product which is the subject of this Order may be subjected to verification of conformity to Kenya standards, approved specifications and other applicable regulations in the exporting country or transshipment port by the inspection body appointed under paragraph 6.

Verification of conformity.

(2) Notwithstanding the provisions of subparagraph (1), the Bureau may reinspect the imported product at a port of entry if, in the Bureau's opinion, it is necessary to do so.

8. (1) The Bureau or an inspection body appointed under paragraph 6 shall issue a certificate of conformity, certificate of inspection or certificate of roadworthiness in respect of a product that conforms to Kenya standards, approved specifications and other applicable regulations.

Certificate of conformity and non-conformity report.

(2) The Bureau or an inspection body appointed under paragraph 6 shall issue a non-conformity report in respect of a product that does not conform to Kenya standards, approved specifications and other applicable regulations.

(3) A product that does not conform to Kenya standards, approved specifications and other applicable regulations shall not be permitted to be imported into Kenya and shall be re-exported to the exporting country or destroyed at the importer's expense.

9. (1) A product which is the subject of this Order which arrives at a port of entry without a certificate of conformity, certificate of inspection or certificate of roadworthiness shall be subjected to destination inspection at a fee equal to five per cent of the approved customs value of the product.

Destination inspection.

(2) The importer of a product which is the subject of this Order which arrives at a port of entry without a certificate of conformity, certificate of inspection or certificate of roadworthiness shall, in addition to the fee specified in subparagraph (1), execute a security bond in favour of the Bureau equal to five per cent of the approved customs value of the product.

(3) A product which is the subject of this Order which arrives at a port of entry without a certificate of conformity, certificate of inspection or certificate of roadworthiness shall be held at the port of entry or kept in an approved warehouse for the purposes of inspection and testing.

(4) A product which is the subject of this Order which arrives at a port of entry without a certificate of conformity, certificate of inspection or certificate of roadworthiness from an exporting country where the Bureau has not appointed an inspection body shall be subjected to destination inspection at the importer's expense at the rate

that would be applicable if inspection had been undertaken in the exporting country by an inspection body appointed by the Bureau.

10. The Cabinet Secretary may, on the advice of the Council, exempt any product from the provisions of this Order if the Cabinet Secretary is satisfied that it is in the national interest to do so.

Exemption from Order.

11. The Standards (Verification of Conformity to Kenya Standards and Other Applicable Regulations) Regulations, 2019, are revoked.
